

Terms and conditions (TAC) to use OCR's website

Overview

These are the Terms and conditions for the use of the site of the Organisation of Civic Rights (OCR) that is based Durban, South Africa. It is a community-based organisation established in April 1984.

1. Using OCR's Site, seeking advice and accessing information

All use of and access to the OCR Web site at www.ocr.org.za ("Site") and the use of the related services offered on the Site ("Services") are subject to the Terms and conditions (TAC) outlined hereunder to use OCR's website.
